

SAVINGS INSTITUTIONS AND BANKS THAT HAVE HAD THEIR NAME CHANGED OR HAVE BEEN ACQUIRED, MERGED OR CLOSED

NOTE: (1) "Merger" in a few cases, particularly with building & loan associations, was a sale of assets. (2) "Name change" in some instances involved a change in charter from state to federal, federal to state or savings & loan association to savings bank. (3) "S&L Assn." and "SLA" mean savings & loan association. (4) "B&L Assn." means building & loan association. (5) "FSB" means federal savings bank. (6) "FA" means federal association. (7) "NA" stands for national association and means it is a nationally chartered commercial bank. (8) "RTC" means Resolution Trust Corporation, a federal agency set up to take over and resolve savings associations with too little capital or other problems. The Federal Deposit Insurance Corporation (FDIC) is the successor to the RTC, which is no longer in existence. (9) "P&A" means purchase of assets and assumption of liabilities.
